#### 2.1 Information about the instruction manual

#### 2.1.1 Introduction

The instruction manual supplied with the burner:

- ➤ is an integral and essential part of the product and must not be separated from it; it must therefore be kept carefully for any necessary consultation and must accompany the burner even if it is transferred to another owner or user, or to another system. If the manual is lost or damaged, another copy must be requested from the Technical Assistance Service of the area;
- > is designed for use by qualified personnel;
- offers important indications and instructions relating to the installation safety, start-up, use and maintenance of the burner.

#### Symbols used in the manual

In some parts of the manual you will see triangular DANGER signs. Pay great attention to these, as they indicate a situation of potential danger.

#### 2.1.2 General dangers

The dangers can be of 3 levels, as indicated below.

#### Delivery of the system and the instruction manual

When the system is delivered, it is important that:

- ➤ the instruction manual is delivered to the user by the system manufacturer, with the recommendation to keep it in the room where the heat generator is to be installed.
- ➤ The instruction manual shows:
  - the serial number of the burner;

the address and telephone number of the nearest Assistance Centre.

- ➤ The system supplier must carefully inform the user about:
  - the use of the system;
  - any further tests that may be required before activating the system;
  - maintenance, and the need to have the system checked at least once a year by a representative of the manufacturer or another specialised technician.

To ensure a periodic check, the manufacturer recommends the drawing up of a Maintenance Contract.

### 2.2 Guarantee and responsibility

The manufacturer guarantees its new products from the installation date, in accordance with the regulations in force and/or the sales contract. At the moment of the first start-up, check that the burner is integral and complete.



Failure to observe the information given in this manual, operating negligence, incorrect installation and carrying out of non authorised modifications will result in the annulment by the manufacturer of the guarantee that it supplies with the burner.

In particular, the rights to the guarantee and the responsibility will no longer be valid, in the event of damage to things or injury to people, if such damage/injury was due to any of the following causes:

- incorrect installation, start-up, use and maintenance of the burner:
- > improper, incorrect or unreasonable use of the burner;
- intervention of unqualified personnel;
- > carrying out of unauthorised modifications on the equipment;
- use of the burner with safety devices that are faulty, incorrectly applied and/or not working;
- installation of untested supplementary components on the burner;
- > powering of the burner with unsuitable fuels;
- ➤ faults in the fuel supply system;
- > continuation of use of the burner when a fault has occured
- repairs and/or overhauls incorrectly carried out;
- modification of the combustion chamber with inserts that prevent the regular development of the structurally established flame;
- insufficient and inappropriate surveillance and care of those burner components most likely to be subject to wear and tear.
- the use of non-original components, including spare parts, kits, accessories and optional;
- force majeure.

# The manufacturer furthermore declines any and every responsibility for the failure to observe the contents of this manual.

Riello warranty is subject to correct burner, appliance and application matching, and set up in line with Riello's instructions and guidelines. All components within the hydraulic circuit suitable for bio fuel use and supplied by Riello will be identified as Bio compatible. No warranty is given in relation to the use of components which are not so identified with bio fuel blends. If in any doubt please contact Riello for further advice.

If any Riello burners are used with fuel with a bio content >10% then the components within the hydraulic circuit maybe affected and are not covered under warranty. The hydraulic circuit consists of:

- Pump
- Hydraulic ram (where applicable)
- Valve block
- Flexible oil lines (considered as a consumable component)
- Irrespective of any warranty given by Riello in relation to normal use and manufacturing defects, when fuels not meeting the relevant standards are used, or where fuel storage issues have not been addressed correctly, or the equipment used is not compatible, if failures occur which are directly or indirectly attributed to such issues and/or to the non-observance of this guidance, then no warranty or liability is implied or accepted by Riello.
- Riello have carefully chosen the specification of the bio compatible components including the flexible oil lines to protect the pump, safety value and nozzle. The Riello warranty is dependent upon the use of Riello genuine components including the oil lines, being used.
- Riello warranty does not cover defects arising from incorrect commissioning or servicing by non Riello employed service engineers, and any issues impacting the burner arising from external site related issues.

### 2.3 Guidance for the use of bio fuel blends up to 10%

#### **Background**

With increasing focus on renewable and sustainable energy requirements, Bio fuel usage is set to increase. Riello is committed to promoting energy conservation and the use of renewable energy from sustainable resources including liquid bio fuels, however there are some technical aspects that must be considered at the planning stage of using such fuels to reduce the potential for equipment failure or the risks of fuel leakage.

Liquid Bio fuel is a generic description used for oil that can come from numerous feed stocks including recycled cooking oils. These types of oils have to be considered and treated differently from standard mineral or fossil fuels, as they are generally more acidic, hydroscopic and less stable.

Due to this, a holistic approach is needed from the specification of the liquid Bio fuel, the storage of the fuel, its oil supply line and ancillary equipment, and very importantly the oil filtration and the burner itself. The specification for FAME (Fatty Acids Methyl Ester) liquid Bio fuel is critical to reliable equipment operation.

It is a minimum requirement that the fuel blend (up to 10% Bio) is obtained with gasoil in accordance with the relevant EN standards, regional regulations and FAME in accordance with EN 14214. It is also important that the fuel blends meet the require-

ments related to operational environment conditions within the relevant EN standards.

When choosing your Riello oil products where you know Bio fuels will be in use, please make sure that a Bio compatible burner and/ or components have been supplied. If an existing burner is to be used with a liquid Bio fuel then a kit may be required to make it compatible and the guidance notes enclosed concerning oil storage and filtration must be adhered to. The end user is responsible for the thorough verification of the potential risks associated with the introduction of a bio fuel blend and the suitability of the appliances and installation applicable.

Irrespective of any warranty given by Riello in relation to normal use and manufacturing defects, when fuels not meeting the relevant standards are used, or where fuel storage issues have not been addressed correctly, or the equipment used is not compatible, if failures occur which are directly or indirectly attributed to such issues and/or to the non-observance of this guidance, then no warranty or liability is implied or accepted by Riello.



### Information and general warnings

#### 2.3.1 Information and general instructions

To ensure consistency, the supplier of the fuel must be able to demonstrate compliance with a recognised Quality Control and management system to ensure high standards are maintained within the storage, blending and delivery processes. The installation oil storage tank and its ancillaries must also be prepared BEFORE liquid Bio fuel is introduced. Checks and preparation should include:

- ➤ For new installations, make sure that all materials and seals in the oil storage and supply line to the burner are compatible with Bio fuels. For all installations, there must be a good quality bio compatible oil filter at the tank and then a secondary filter of 100 Microns protecting the burner from contamination.
- ➤ If an existing oil storage tank is to be used then in addition to the materials checks as detailed above, it will be essential that the tank is first inspected for condition and checked for water or other contamination. Riello strongly recommends that the tank is cleaned and oil filters replaced prior to Bio fuel delivery. If this is not completed then due to the hydroscopic nature of Bio fuel, it will effectively clean the tank, absorb water present which in turn will result in equipment failure that is not covered by the manufacturer's warranty.
- ➤ Depending on the capacity of the oil storage tank and oil usage, fuels may remain static within the tank for some considerable time and so Riello recommends that the oil distributor is consulted regarding the use of additional Biocides within the fuel to prevent microbial growth from occurring within the tank. Riello suggests that fuel suppliers and or service companies are contacted for guidance on fuel filtration. Special attention should be applied to duel fuel applications where oil may be stored for long periods of time.
- ➤ The burner must be set according to the appliance application and commissioned checking that all combustion parameters are as recommended in the appliance technical manual.
- ➤ Riello recommends that the in line and burner oil pump filters are inspected and if required replaced at least every 4 months during burner use, before the burner start-up following a long period of discontinue operation and even more frequently where contamination has occurred. Particular attention is needed when inspecting and checking for fuel leakages from seals, gaskets and hoses.

### 3

### Safety and prevention

#### 3.1 Introduction

The burners have been designed and built in compliance with current regulations and directives, applying the known technical rules of safety and envisaging all the potential danger situations.

It is necessary, however, to bear in mind that the imprudent and clumsy use of the equipment may lead to situations of death risk for the user or third parties, as well as the damaging of the burner or other items. Inattention, thoughtlessness and excessive confidence often cause accidents; the same applies to tiredness and sleepiness.

It is a good idea to remember the following:

➤ The burner must only be used as expressly described. Any other use should be considered improper and therefore dangerous.

#### In particular:

it can be applied to boilers operating with water, steam, diathermic oil, and to other uses expressly named by the manufacturer;

the type and pressure of the fuel, the voltage and frequency of the electrical power supply, the minimum and maximum deliveries for which the burner has been regulated, the pressurisation of the combustion chamber, the dimensions of the combustion chamber and the room temperature must all be within the values indicated in the instruction manual.

- Modification of the burner to alter its performance and destinations is not allowed.
- ➤ The burner must be used in exemplary technical safety conditions. Any disturbances that could compromise safety must be quickly eliminated.
- ➤ Opening or tampering with the burner components is not allowed, apart from the parts requiring maintenance.
- ➤ Only those parts detailed as available as spare parts by the Manufacturer can be replaced.

#### 3.2 Safety warnings

The dimension of the boiler's combustion chamber must respond to specific values, in order to guarantee a combustion with the lowest polluting emissions rate.

The Technical Service Personnel will be glad to give you all the imformation for a correct matching of this burner to the boiler.

This burner must only be used for the application it was designed for.

The manufacturer accepts no liability within or without the contract for any damage caused to people, animals and property due to installation, adjustment and maintenance errors or to improper use.

#### 3.3 Basic safety rules

- ➤ Children or inexpert persons must not use the appliance.
- ➤ Under no circumstances must the intake grids, dissipation grids and ventilation vents in the installation room be covered up with cloths, paper or any other material.
- Unauthorised persons must not attempt to repair the appliance.
- ➤ It is dangerous to pull or twist the electric leads.
- Cleaning operations must not be performed if the appliance is not disconnected from the main power supply.
- ➤ Do not clean the burner or its parts with inflammable substances (e.g. petrol, alcohol, etc.). The cover must be cleaned with soapy water.
- ➤ Do not place anything on the burner.
- Do not block or reduce the size of the ventilation vents in the installation room.
- ➤ Do not leave containers and inflammable products or combustible materials in the installation room.

### 3.4 Personnel training

The user is the person, body or company that has acquired the machine and intends to use it for the specific purpose. He is responsible for the machine and for the training of the people working around it.


#### The user:



The burner can work in two ways: one-stage and two-stage.


1<sup>st</sup> stage DELIVERY must be selected within area A of the adjacent diagrams.

 $2^{nd}$  stage DELIVERY must be selected within area B.

This area provides the maximum delivery of the burner in relation to the pressure in the combustion chamber.



The firing rate value (Fig. 2) has been obtained considering an ambient temperature of 20 °C, an atmospheric pressure of 1013 mbar (approx. 0 m above sea level), and with the combustion head adjusted as shown on page 23.





#### 4.7.1 Test boiler

The firing rate was set in relation to special test boilers in accordance with the methods defined in EN 267 standards.

Fig. 3 indicates the diameter and length of the test combustion chamber.

### Example for RL 400/B MZ:

delivery 3000 kW: diameter = 100 cm; length = 4 m.



The burner/boiler matching does not pose any problems if the boiler is CE type-approved and its combustion chamber dimensions are similar to those indicated in diagram (Fig. 3).

If the burner must be combined with a boiler that has not been CE type-approved and/or its combustion chamber dimensions are clearly smaller than those indicated in diagram (Fig. 3), consult the manufacturer.



The burner can be opened either on the right or left sides, irrespective of the side from which fuel is supplied.

When the burner is closed, the hinge can be re-positioned on the opposite side.



### 4.8.1 Description of panel board

- 1 Relay outlet voltage free contacts
- 2 Ignition transformer
- 3 Stop push-button
- 4 Dial for off automatic manual
- 5 1<sup>st</sup> 2<sup>nd</sup> stage selector
- 6 Signal light for auxiliary voltage
- 7 Motor thermal cutout tripped warning light
- 8 Signal light for burner failure and lock-out reset button
- 9 Control box
- 10 Star-powered/delta-powered starter (only RL 400/B MZ)
- 11 Timer (only RL 400/B MZ)
- 12 Main supply terminal strip

Two types of burner failure may occur:

#### Control box lock-out:

if the control box 9)(Fig. 5) pushbutton (**red led**) and the reset button 8)(Fig. 5) light up, it indicates that the burner is in lock-out. To reset, hold the pushbutton down for between 1 and 3 seconds.


#### Motors trip:






### Installation

#### 5.1 Notes on safety for the installation

After carefully cleaning all around the area where the burner will be installed, and arranging the correct lighting of the environment, proceed with the installation operations.



All the installation, maintenance and disassembly operations must be carried out with the electricity supply disconnected.



The installation of the burner must be carried out by qualified personnel, as indicated in this manual and in compliance with the standards and regulations of the laws in force.

### 5.2 Handling

The packaging of the burner includes a wooden platform, so it is possible to move the burner (still packaged) with a transpallet truck or fork lift truck.



The handling operations for the burner can be highly dangerous if not carried out with the greatest attention: keep any unauthorised people at a distance; check the integrity and suitableness of the available means of handling.

Check also that the area in which you are working is empty and that there is an adequate escape area (i.e. a free, safe area to which you can quickly move if the burner should fall).

When handling, keep the load at not more than 20-25 cm from the ground.



After positioning the burner near the installation point, correctly dispose of all residual packaging, separating the various types of material.

Before proceeding with the installation operations, carefully clean all around the area where the burner will be installed.

### 5.3 Preliminary checks

#### Checking the consignment



After removing all the packaging, check the integrity of the contents. In the event of doubt, do not use the burner; contact the supplier.




The packaging elements (wooden cage or cardboard box, nails, clips, plastic bags, etc.) must not be abandoned as they are potential sources of danger and pollution; they should be collected and disposed of in the appropriate places.

### Checking the characteristics of the burner

Check the identification label of the burner, showing:

- ➤ the model (A)(Fig. 7) and type of burner (B);
- ➤ the year of manufacture, in cryptographic form (C);
- the serial number (D);
- ➤ the electrical input power (E);
- ➤ the types of fuel used and the relative supply pressures (**F**);
- ➤ the data of the burner's minimum and maximum output possibilities (G) (see Firing rate).

The output of the burner must be within the boiler's firing rate:



A burner label, or any other component, that has been tampered with, removed or is missing, prevents the definite identification of the burner and makes any installation or maintenance work difficult.

### 5.4 Installer/Servicer notes for the use of Gas oil with Bio blends up to 10%

- ➤ During the burner installation, check that the gasoil and bio fuel blends are in accordance with Riello specifications (please refer to the chapters "Technical Data" and "Guidance for the use of bio fuel blends up to 10%" within the burner technical manual).
- ➤ If a Bio blend is in use the installer must seek information from the end user that their fuel supplier can evidence that the blends of fuel conform to the relevant standards.
- ➤ Check that the materials used in the construction of the oil tank and ancillary equipment are suitable for bio fuels, If not these must be upgraded or replaced with Bio compatible parts.
- ➤ Particular attention should be given to the oil storage tank and supply to the burner. Riello recommends that existing oil storage tanks are cleaned, inspected and any traces of water are removed BEFORE bio fuel is introduced (Contact the tank manufacturer or oil supplier for further advice). If these recommendations are not respected this will increase the risk of contamination and possible equipment failure.
- In line oil filters should be replaced making sure that they are Bio compatible. Riello recommends a good quality bio com-

- patible oil filter at the tank and a secondary 100 micron filter are used to protect the burner pump and nozzle from contamination.
- ➤ The burner hydraulic components and flexible oil lines must be suitable for bio fuel use (check with Riello if in doubt). Riello have carefully chosen the specification of the bio compatible components including the flexible oil lines to protect the pump, safety value and nozzle. The Riello warranty is dependent upon the use of Riello genuine components including the oil lines, being used. The burner must be commissioned and combustion parameters set to appliance manufacturer's recommendations.
- ➤ Regularly check visually for any signs of oil leakage from seals, gaskets and hoses.
- ➤ It is strongly recommended that with Bio fuel use, oil filters are inspected and replaced every 4 months. More regularly where contamination is experienced.
- ➤ During extended periods of non operation and/or where burners are using oil as a standby fuel, it is strongly recommended that the burner is put into operation for shorts periods at least every three months.

### 5.5 Operating position

The burner is designed to work only in the positions 1, 2, 3 and 4. Installation 1 is preferable, as it is the only one that allows performing maintenance operations as described in this manual. Installations 2, 3 and 4 permit operation but make maintenance

and inspection of the combustion head difficult, page 27.



Any other position could compromise the correct working of the appliance.

Installation 5 is prohibited for safety reasons.






### 5.6 Removal of the locking screws from the shutter



Remove the screws and the nuts 1)-2)(Fig. 9), before installing the burner on the boiler.

Replace them with the screws 3) M12 X 25 supplied with the burner.





### 5.7 Boiler plate

Drill the combustion chamber locking plate as shown in Fig. 10. The position of the threaded holes can be marked using the thermal screen supplied with the burner.



### 5.8 Blast tube length

The length of the blast tube 4)(Fig. 11) must be selected according to the indications provided by the manufacturer of the boiler, and in any case it must be greater than the thickness of the boiler door complete with its fettling.

For boilers with front flue passes 1) or flame inversion chambers, protective fettling in refractory material 5) must be inserted between the boiler fettling 2) and the blast tube 4).

This protective fettling must not compromise the extraction of the blast tube.

For boilers having a water-cooled front the refractory fettling 2)-5) is not required unless it is expressly requested by the boiler manufacturer.

#### 5.9 Securing the burner to the boiler

- Prepare an adequate system of hoisting by hooking onto the rings 3)(Fig. 11).
- ➤ Slip the thermal protection (standard equipment) onto the blast tube 4)(Fig. 11).
- ➤ Place entire burner on the boiler hole (arranged previously, see Fig. 10, and fasten with the screws given as standard equipment.



The coupling of the burner-boiler must be air-tight.

# 5.9.1 Accessibility to the interior of the combustion head

- Open burner at hinge (Fig. 12) after removing the 4 fixing screws 1).
- ➤ Disconnect the plug 6)
- Disconnect the wires from the electrodes 2).
- ➤ Unscrew the screw 4) that fix combustion head
- Disconnect the oil pipes by unscrewing the two connectors 3).



While unscrewing, some fuel may leak out.

Extract the internal part 5) of the combustion head.





#### 5.10 Nozzle installation

The burner complies with the emission requirements of the EN 267 standard.

In order to guarantee that emissions do not vary, recommended and/or alternative nozzles specified by Riello in the Instruction and warning booklet should be used.



It is advisable to replace nozzles every year during regular maintenance operations.



The use of nozzles other than those specified by Riello S.p.A. and inadequate regular maintenance may result into emission limits non-conforming to the values set forth by the regulations in force, and in extremely serious cases, into potential hazards to people and objects.

The manufacturing company shall not be liable for any such damage arising from nonobservance of the requirements contained in this manual.

#### 5.10.1 Nozzles reccomended

- Type HAGO S-S 60° angle
- Type HAGO LC 60° angle

Instead of the nozzles given in Tab. F, you can use the following nozzle types:

 MONARCH PLP 70° (up to 50 GPH) as nozzles to be used instead of type HAGO S-S 60° given in Tab. F.

#### **RL 300/B MZ**

- HAGO H (up to 30 GPH) to cover area A in firing rate on page 11
- MONARCH PL 70° (up to 30 GPH) to cover area A in firing rate on page 11.

#### **RL 400/B MZ**

DELEVAN B 60° (or 80° up to 50 GPH) to cover area A in firing rate on page 11.

### 5.10.2 Choice of nozzles for 1st and 2nd stage

Both nozzles must be chosen from among those listed in Tab. F.

- ➤ The first nozzle determines the delivery of the burner in the 1<sup>st</sup> stage.
- ➤ The second nozzle works together with the 1<sup>st</sup> nozzle to determine the delivery of the burner in the 2<sup>nd</sup> stage.

The deliveries of the 1<sup>st</sup> and 2<sup>nd</sup> stages must be contained within the value range indicated on page 9.



Use nozzles with a  $60^{\circ}$  spray angle at the recommended pressure of 12 bar.

As a rule the two nozzles have equal deliveries but the 1<sup>st</sup> stage nozzle may have a delivery less than 50% of the total delivery when a reduction of the counter-pressure peak is desired at the moment of starting (the burner allows good combustion rates also with a 33 - 100 % ratio between the 1<sup>st</sup> and 2<sup>nd</sup> stage).

#### **Example:**

Boiler output = 2621 kW - efficiency 90 %

Output required by the burner = 2621 : 0.9 = 2912 kW;

2912 : 2 = 1456 KW per nozzle;

therefore, two equal, 60°, 12 bar nozzles are required:

 $1^{\circ} = 30 \text{ GPH} - 2^{\circ} = 30 \text{ GPH}$ 

or the following two different nozzles:

1° = 35 GPH - 2° = 25 GPH

#### 5.10.3 Nozzle assembly

Fit two nozzles with the box spanner 1)(Fig. 13) (16 mm), after having removed the plastic plugs 2), fitting the spanner through the central hole in the flame stability disk 3).



Do not use any sealing products such as gaskets, sealing compound, or tape.


Be careful to avoid damaging the nozzle sealing seat

The nozzles must be screwed into place tightly but not to the maximum torque value provided by the wrench.

The nozzle for the 1<sup>st</sup> stage of operation is the one lying beneath the firing electrodes Fig. 14.







### 5.12 Gas oil supply



Where gas oil containing bio diesel is in use, it is recommended to avoid over oxygenation of the blended fuels.

Where at all possible avoid the use of two pipe systems where the circulated fuel is returned to the tank.

If this cannot be avoided make sure that the return pipe is normally below the surface of the fuel level within the storage tank.



In case of use with gas oil containing up to 10% Bio blend, it will be essential to use flexible oil lines suitable for bio fuel use.

Please contact Riello for further information.



It is strongly recommended a periodic check of the pump pressure operation (annually or better every six months, if the burner operation is continuous).



You are advised to use additional filters on the fuel supply line.

Riello recommends a good quality fuel filter at the tank (Fig. 15 - Fig. 16) and a secondary filter (100  $\mu$  for gas oil and 15  $\mu$  for kerosene) are used to protect the burner pump and nozzle from contamination.

In case of Biodiesel use, pay attention to install Biocompatible filters.

#### 5.12.1 Double-pipe circuit

The burner is equipped with a self-priming pump which is capable of feeding itself within the limits listed in the Tab. G.

#### The tank higher than the burner A (Fig. 15)

The distance "P" must not exceed 10 meters in order to avoid subjecting the pump's seal to excessive strain; the distance "V" must not exceed 4 meters in order to permit pump self-priming even when the tank is almost completely empty.

#### The tank lower than the burner B (Fig. 15)

Pump depression values higher than 0.45 bar (35 cm Hg) must not be exceeded because at higher levels gas is released from the fuel, the pump starts making noise and its working life-span decreases.

It is good practice to ensure that the return and suction lines enter the burner from the same height; in this way it will be more improbable that the suction line fails to prime or stops priming.

#### 5.12.2 The loop circuit

A loop circuit consists of a loop of piping departing from and returning to the tank with an auxiliary pump that circulates the fuel under pressure.

A branch connection from the loop goes to feed the burner. This circuit is extremely useful whenever the burner pump does not succeed in self-priming because the tank distance and/or height difference are higher than the values listed in the Tab. G.

#### Note:

we advise you to fit, on the loop circuit, an oil pressure switch connected to the thermostatic series. It will provide clearance to the burner only if there ispressure.



### 5.12.3 Single-pipe circuit

In order to obtain single-pipe working it is necessary to unscrew the return hose, remove the by-pass screw 6)(Fig. 17) and then screw the plug 7).

The distance "P" must not exceed 10 meters in order to avoid subjecting the pump's seal to excessive strain; the distance "V" must not exceed 4 meters.

For the priming pump loosen the screw 4)(Fig. 18) in order to bleed off the air contained in the suction line and wait until the fuel



#### 5.13 **Hydraulic connections**

The pumps are equipped with a by-pass that connects return line and suction line. The pumps are installed on the burner with the by-pass closed by screw 6)(Fig. 17).

It is therefore necessary to connect both hoses to the pump. The pump will break immediately if it is run with the return line closed and the by-pass screw inserted.

Remove the plugs from the suction and return connections of the pump.

Insert the hose connections with the supplied seals into the connections and screw them down.




Take care that the hoses are not stretched or twisted during installation.

Install the hoses where they cannot be stepped on or come into contact with hot surfaces of the boiler and where they do not hamper the opening of the burner.

Now connect the other end of the hoses to the suction and return lines by using the supplied nipples.



### 5.15.2 Pump priming



Before starting the burner, make sure that the tank return line is not clogged.

Obstructions in the line could cause the sealing organ located on the pump shaft to break. (The pump leaves the factory with the by-pass closed).

- For self-priming to take place, the screw 4)(Fig. 18) of the pump must be loosened in order to bleed off the air contained in the suction line.
- Start the burner by closing the remote controls. Check the fan wheel rotation direction as soon as the burner starts.
- The pump is primed when gas oil comes out of screw 4)(Fig. 18). Stop the burner and screw screw 4) in.

The time required for this operation depends upon the diameter and length of the suction tubing.

If the pump fails to prime at the first starting of the burner and the burner locks out, wait approx. 15 seconds, reset the burner, and then repeat the starting operation as often as required.

After 5 or 6 starting operations allow 2 or 3 minutes for the transformer to cool.

Do not illuminate the UV cell or the burner will lock out; the burner should lock out anyway about 10 seconds after it starts.



The a.m. operation is possible because the pump is already full of fuel when it leaves the factory.

If the pump has been drained, fill it with fuel through the opening on the vacuum meter 4)(Fig. 18) prior to starting; otherwise, the pump will seize.

Whenever the length of the suction piping exceeds 20-30 meters, the supply line must be filled using a separate pump

### **Electrical system**

#### 6.1 Notes on safety for the electrical wiring



- ➤ The electrical wiring must be carried out with the electrical supply disconnected.
- ➤ Electrical wiring must be carried out by qualified personnel and in compliance with the regulations currently in force in the country of destination. Refer to the wiring diagrams.
- ➤ The manufacturer declines all responsibility for modifications or connections different from those shown in the wiring diagrams.
- ➤ Do not invert the neutral with the phase in the electrical supply line. Any inversion would cause a lockout due to firing failure.
- > Check that the electrical supply of the burner corresponds to that shown on the identification label and in this manual.
- ➤ The burners have been set for intermittent operation. This means they should compulsorily be stopped at least once every 24 hours to enable the control box to perform checks of its own start-up efficiency. Normally the boiler's thermostat/pressure switch ensures the stopping of the burner.
  - If this is not the case, it is necessary to apply in series with IN a timer switch that turns off the burner at least once every twenty-four hours. Refer to the wiring diagrams.
- ➤ The electrical safety of the device is obtained only when it is correctly connected to an efficient earthing system, made according to current standards. It is necessary to check this fundamental safety requirement. In the event of doubt, have the electrical system checked by qualified personnel.
- The electrical system must be suitable for the maximum input power of the device, as indicated on the label and in the manual, checking in particular that the section of the cables is suitable for the input power of the device.
- ➤ For the main power supply of the device from the electricity mains:
  - do not use adapters, multiple sockets or extensions;
  - use an omnipolar switch, as indicated by the current safety standards.
- ➤ Do not touch the device with wet or damp body parts and/or in bare feet.
- ➤ Do not pull the electric cables.

Before carrying out any maintenance, cleaning or checking operations:



disconnect the electrical supply from the burner by means of the main system switch;



isolate the fuel supply.

If the cover is still present, remove it and proceed with the electrical wiring according to the wiring diagrams.

#### 6.2 Electrical connections



Electrical wiring must be made in accordance with the regulations currently in force in the country of destination and by qualified personnel.

Riello S.p.A. declines all liability for modifications or connections other than those shown on these diagrams.

Refer to the paragraph "Entry for power cables and external leads" at page 13.

### Start-up, calibration and operation of the burner

#### 7.1 Notes on safety for the first start-up



The first start-up of the burner must be carried out by qualified personnel, as indicated in this manual and in compliance with the standards and regulations of the laws in force.



Check the correct working of the adjustment, command and safety devices.

### 7.2 Burner firing

Set switch 1)(Fig. 19) to "MAN".

During the first firing, during the passage from the 1<sup>st</sup> to the 2<sup>nd</sup> stage, switch 2)(Fig. 19) there is a momentary lowering of the fuel pressure caused by the filling of the 2<sup>nd</sup> stage nozzle tubing.

This lowering of the fuel pressure can cause the burner to lockout and can sometimes give rise to pulsations.

Once the following adjustments have been made, the firing of the burner must generate a noise similar to the noise generated during operation.



#### 7.3 Burner calibration

The optimum calibration of the burner requires an analysis of the flue gases at the boiler outlet.

Adjust successively:

- Combustion head
- 1<sup>st</sup> and 2<sup>nd</sup> stage nozzles
- Pump pressure
- 1<sup>st</sup> and 2<sup>nd</sup> stage fan air gate valve

#### 7.3.1 Combustion head setting

The setting of the combustion head depends exclusively on the burner delivery.

Loosen the screw 1)(Fig. 20) and turn the graduated sector 2) according diagram (Fig. 21).

#### **Example:**

the burner RL 400/B MZ with two 30 GPH nozzles and 12 bar pump pressure.

Find the delivery of the two 30 GPH nozzles in (Tab. F at page 17): 1455.9 + 1455.9 = 2911.8 kW.

Diagram (Fig. 21) indicates that for a delivery of 2911.8 kW the burner requires the combustion head to be set to approx. 3 notches.

### 7.3.2 1<sup>st</sup> and 2<sup>nd</sup> stage nozzles

See the information listed at page 17.

#### 7.3.3 Pump pressure

12 bar: this is the pressure calibrated in the factory which is usually sufficient for most purposes.

Sometimes, this pressure must be adjusted to:

10 bar: in order to reduce fuel delivery. This adjustment is possible only if the surrounding temperature remains above 0 °C;

14 bar: in order to increase fuel delivery or to ensure firings even at temperatures of less than 0 °C. In order to adjust pump pressure, use the screw 5)(Fig. 18 at

page 21).





7.3.4 1<sup>st</sup> and 2<sup>nd</sup> stage fan air gate valve

See adjustments of the servomotor.



### Start-up, calibration and operation of the burner

#### 7.4 Servomotor

The servomotor (Fig. 22), by means of connection mechanisms, simultaneously regulates air pressure and delivery and the flow of fuel in use. It features adjustable cams that operate as many switches.

Cam 1: blue

limits servomotor travel to  $0^{\circ}$  position. With the burner off, the air damper is fully closed.

Cam 2: orange

adjusts the position of the air damper to 1<sup>st</sup> stage or pre-purging (factory set to 22° position).

Cam 3: red

adjusts air damper travel or 2<sup>nd</sup> stage operation without exceeding 90° (factory set to 60° position).


Cam 4: black

determines how early 2<sup>nd</sup> stage valve is switched on.



Under no circumstances should the blue cam be moved to the left, beyond the air damper closing position.

Under no circumstances should the red cam be moved to the right beyond 90°.



### 7.5 Air adjustment for maximum output

Set the servomotor to maximum opening (near 90°) so that the air butterfly valves are fully open.

Loosen screw 2)(Fig. 23) under the burner's intake and close grille 1) progressively until you achieve the required output.

The only time reducing intake to a partial setting is not necessary is when the burner is working at the top of the operating range given on page 11.



We recommend you achieve the maximum output required manually, and adjust intake to the partial setting and adjust the combustion head before completing servomotor setting.



#### 7.6 Low-limit oil pressure switch

The low-limit oil pressure switch inhibits burner ignition at a pressure below the pump's setting.

See Tab. F to page 17 (it comes with a factory setting of 8 bar).

If pressure is below the pump setting, the start-up cycle begins as usual but, when the burner is to ignite, it locks out owing to the oil pressure switch tripping.

Adjustment is made using screw B)(Fig. 24).



### 7.7 Air pressure switch - CO check

Adjust the air pressure switch after having performed all other burner adjustments with the air pressure switch set to the start of the scale (Fig. 25).

With the burner running at maximum output, measure CO emission in the flue gases, then progressively obstruct the air intake with the aid of the regulating grille 1)(Fig. 23 to page 24) and, if this is not enough, using a rigid bulkhead, until the CO comes close to the standard limit value (CO  $\leq$  1%  $\leq$  10.000 ppm) without exceeding it.

In this working situation, to increase regulation, slowly turn the special knob on the pressure switch until the burner locks out. Finally remove the obstruction from the suction inlet and check the burner fires correctly.



#### 7.8 Burner operation

#### 7.8.1 Burner starting

Starting phases with progressive time intervals shown in seconds:

Control device TL closes.

After about 3s:

**0 s:** the control box starting cycle begins.

2 s: the fan motor starts. Servomotor 12)(Fig. 27) starts, air damper opens in 1<sup>st</sup> stage position.

**3 s:** the ignition transformer is connected.

The pump 3)(Fig. 26) sucks the fuel from the tank through the piping 1) and the filter 2) and pumps it under pressure to delivery.

The piston 4) rises and the fuel returns to the tank through the piping 5) - 7).

The screw 6) closes the by-pass heading towards suction and the solenoid valves 8) - 9) - 10), de-energized, close the passage to the nozzles.


**22 s:** solenoid valves 8) and 9) open and the fuel is sprayed out through the nozzle, igniting when it comes into contact with the spark.

This is the 1st stage flame.

29 s: the ignition transformer switches off.

**36 s:** if the control device TR is closed or has been replaced by a jumper wire, the 2<sup>nd</sup> stage solenoid valve 10) opens and the servomotor moves the air damper to 2<sup>nd</sup> stage position.

The starting cycle comes to an end.

### Start-up, calibration and operation of the burner

### 7.8.2 Steady state operation

#### System equipped with one control device TR

Once the starting cycle has come to an end,set 0-auto-man selector to auto the command of the 2<sup>nd</sup> stage solenoid valve passes on to the control device TR that controls boiler temperature or pressure.

- ➤ When the temperature or the pressure increases until the control device TR opens, solenoid valve 10)(Fig. 26) closes, and the burner passes from the 2<sup>nd</sup> to the 1<sup>st</sup> stage of operation
- ➤ When the temperature or pressure decreases until the control device TR closes, solenoid valve 10) opens, and the burner passes from the 1<sup>st</sup> to the 2<sup>nd</sup> stage of operation, and so on.
- ➤ The burner stops when the demand for heat is less than the amount of heat delivered by the burner in the 1<sup>st</sup> stage. In this case, the control device TL opens, and solenoid valves 8)-9) close, the flame immediately goes out. The fan's air gate valve closes completely.

# Systems not equipped with control device TR (jumper wire installed)

The burner is fired as described in the case above.

If the temperature or pressure increase until control device TL opens, the burner shuts down (Section A-A in the diagram Fig. 27).

#### 7.8.3 Firing failure

If the burner does not fire, it goes into lock-out within 5 s of the opening of the 1<sup>st</sup> stage valve and 30 s after the closing of control device TL.

The control box red pilot light will light up.

#### 7.8.4 Undesired shutdown during operation

If the flame goes out during operation, the burner shuts down automatically within 1 second and automatically attempts to start again by repeating the starting cycle.

#### 7.9 Final checks

- ➤ Obscure the photocell and switch on the control devices: the burner should start and then lock-out about 5 s after opening of the 1st stage operation valve.
- ➤ Illuminate the photocell and switch on the control devices: the burner should start and then go into lock-out after about 10 s.
- ➤ Obscure the photocell while the burner is in 2nd stage operation, the following must occur in sequence: flame extinguished within 1 s, purging for about 20 s, sparking for about 5 s, burner goes into lock out.
- Switch off control device TL followed by control device TS while the burner is operating: the burner should stop.

#### **Maintenance**

#### 8.1 Notes on safety for the maintenance

The periodic maintenance is essential for the good operation, safety, yield and duration of the burner.

It allows you to reduce consumption and polluting emissions and to keep the product in a reliable state over time.



The maintenance interventions and the calibration of the burner must only be carried out by qualified, authorised personnel, in accordance with the contents of this manual and in compliance with the standards and regulations of current laws.

Before carrying out any maintenance, cleaning or checking operations:



Disconnect the electrical supply from the burner by means of the main system switch.



Close the fuel interception tap.

#### 8.2 Maintenance programme

### 8.2.1 Maintenance frequency

The combustion system should be checked at least once a year by a representative of the manufacturer or another specialised technician.

#### 8.2.2 Checking and cleaning

#### Combustion

The optimum calibration of the burner requires an analysis of the flue gases.

Significant differences with respect to the previous measurements indicate the points where more care should be exercised during maintenance.

#### **Combustion head**

Check to make sure that all the parts of the combustion head are in good condition, positioned correctly, free of all impurities, and that no deformation has been caused by operation at high temperatures.

#### Fan

Check to make sure that no dust has accumulated inside the fan or on its blades, as this condition will cause a reduction in the air flow rate and provoke polluting combustion.

#### Boiler

Clean the boiler as indicated in its accompanying instructions in order to maintain all the original combustion characteristics intact, especially the flue gas temperature and combustion chamber pressure.

#### **Burner**

Check for excess wear or loose screws. Also make sure that the screws securing the electrical leads in the burner connections are fully tightened. Clean the outside of the burner.

#### **Photocell**

Clean the glass cover from any dust that may have accumulated. Photocell 1)(Fig. 29) can be removed by pulling it outward forcefully.



#### **Filters**

Check the filtering baskets on line and at nozzle present in the system. Clean or replace if necessary.

If rust or other impurities are observed inside the pump, use a separate pump to lift any water and other impurities that may have deposited on the bottom of the tank.

### **Pump**

The delivery pressure must be stable. The depression must be less than 0.4 bar. Unusual noise must not be evident during pump operation.

If the pressure is found to be unstable or if the pump runs noisily, the flexible hose must be detached from the line filter and the fuel must be sucked from a tank located near the burner. This measure permits the cause of the anomaly to be traced to either the suction piping or the pump.

If the pump is found to be responsible, check to make sure that the filter is not dirty. The vacuometer is installed upstream from the filter and consequently will not indicate whether the filter is clogged or not. Contrarily, if the problem lies in the suction line, check to make sure that the filter is clean and that air is not entering the piping.

Please check that the supply line and filters are clear. The use of a pump vacuum gauge will assist in this. This measure permits the cause of the anomaly to be traced to either the suction line or the pump.



#### **Maintenance**

If the problem lies in the suction line, check to make sure that the filter is clean and that air is not entering the piping.

#### Hoses

- Check periodically the flexible pipes conditions. They have to be replaced at least every 2 years.
- In case of use of gas oil and bio fuel blends, it is strongly recommended to inspect even more frequently the hoses and replace them where contamination has occurred.
- Check to make sure that the hoses are still in good condition.

#### **Nozzles**

Do not clean the nozzle openings; do not even open them. The nozzle filters however may be cleaned or replaced as required. It is advisable to replace nozzles every year during regular maintenance operations. Combustion must be checked after the nozzles have been changed.

#### Fuel tank

If water or contamination is present within the fuel tank, it is essential that this is removed before the equipment is to be used. This is extremely important when gas oil containing Bio diesel is in use. If in doubt about how to achieve this then please contact the fuel or oil tank supplier.

#### Combustion

In case the combustion values found at the beginning of the intervention do not respect the standards in force or, in any case, do not correspond to a proper combustion, contact the Technical Assistant and have him carry out the necessary adjustments.

### 8.4 Resetting the control box and using diagnostics

The control box features a diagnostics function through which any causes of malfunctioning are easily identified (indicator: **RED LED**).

To use this function, you must wait at least 10 seconds once it has entered the safety condition (lock-out), and then press the reset button.

The control box generates a sequence of pulses (1 second apart), which is repeated at constant 3-second intervals.

Once you have seen how many times the light pulses and identified the possible cause, the system must be reset by holding the button down for between 1 and 3 seconds.

The methods that can be used to reset the control box and use diagnostics are given below.

#### 8.4.1 Resetting the control box

To reset the control box, proceed as follows:

Hold the button down for between 1 and 3 seconds.
 The burner restarts after a 2-second pause once the button is released.

If the burner does not restart, you must make sure the limit thermostat is closed.

### 8.4.2 Visual diagnostics

Indicates the type of burner malfunction causing lockout.

To view diagnostics, proceed as follows:

 Hold the button down for more than 3 seconds once the red LED (burner lockout) remains steadily lit.

A yellow light pulses to tell you the operation is done. Release the button once the light pulses. The number of times it pulses tells you the cause of the malfunction, according to the coding system indicated in the table on page 30.

### 8.4.3 Software diagnostics

Reports burner life by means of an optical link with the PC, indicating hours of operation, number and type of lock-outs, serial number of control box etc ...

To view diagnostics, proceed as follows:

 Hold the button down for more than 3 seconds once the red LED (burner lockout) remains steadily lit.
 A yellow light pulses to tell you the operation is done.
 Release the button for 1 second and then press again for over 3 seconds until the yellow light pulses again. Once the button is released, the red LED will flash intermittently with a higher frequency: only now can the optical link be activated.

Once the operations are done, the control box's initial state must be restored using the resetting procedure described above.

### 9 Faults - Possible causes - Solutions

Find a list of faults, causes and possible solutions for a set of failures that may occur and result in irregular burner operation or no functioning at all.

If a burner malfunction is detected, first of all:

- · check that the electrical wiring is adequately connected;
- · check whether fuel is delivered;

#### **DEGASSING UNIT**

It may occur that a certain amount of air is contained in the fuel sucked up by the pump.

This air may originate from the fuel itself as a consequence of depressurisation or air leaking past imperfect seals.

In double-pipe systems, the air returns to the tank from the return pipe; in single-pipe systems, the air remains in circulation causing pressure variations in the pump and burner malfunctions.

For this reason, we advise installing a degassing unit near the burner in single-pipe installations.
